**DATE AND TIME OF INTERVIEW:**

On 01/07/13 from approximately 1230 to 1240 hours.

**ACTION TAKEN:** On 01/02/13 I was assigned to make contact with a [REDACTED] 04, 03 name was listed on the Visitor's Sign In/Out Sheet for Sandy Hook Elementary School for the date of 12/14/2012, the day of the shooting incident. According to the visitor's log, [REDACTED] 04 signed in at 0931 hrs and signed out at 0932 hrs. Refer to attached visitor's log.

On 01/07/13 at approximately 1230 hrs, I interviewed [REDACTED] 04 via the telephone. [REDACTED] 04 verbally stated to me that on 12-14-12, she went to Sandy Hook Elementary School to drop off a letter [REDACTED] 01 02 had forgotten at home. The letter was addressed to [REDACTED] 01 02, and it was to apologize for cheating on a test. [REDACTED] 04 stated that when she pulled into the parking lot, she did not notice anything unusual. She stated that there were no passing cars when she was coming in or out. She went to sign in to the office at 9:31 AM. She stated that there were a couple of parents walking around because there was a gingerbread house building activity going on inside the school and the parents were there to help out and participate. [REDACTED] 04 stated that after signing in, she went to Room [REDACTED] 04 which was just past the office and the library. She dropped off the letter to [REDACTED] 01 02 to give to the teacher and she went back to the office and signed out at 9:32 AM. [REDACTED] 04 stated that she left the parking lot at approximately 9:34.

I asked [REDACTED] 04 if there was anything that struck her as odd or gave her a strange feeling and she stated "yes there was". [REDACTED] 04 stated that there was an older man, approximately 60-65 years old, dressed in dark clothing, with his hands in his pockets. He was walking in and shuffling. She
