clarify some things that she had spoken about in her previous statements given to the State Police. During the interview, Roig stated, in part, the following:

That on the morning of 12-14-12, she and her students were having a morning meeting on the classroom floor. It was calm and quiet. Roig clarified that they were sitting in a circle and because the students were calm and quiet, it made it easy to tell them to go hide in the bathroom.

Roig stated that she heard rapid fire shooting from a warfare type gun, that was what it sounded like to her. Roig clarified that she knew this because her dad hunts and she has watched movies with this type of weapon in the movie. Roig stated that she is also a person who is always on high alert.

Roig stated that upon hearing the gunshots, she got up, closed the door, and turned off the lights. Roig stated that she had no time to get her keys from her desk.

Roig stated that she told her kids to get into the bathroom. She had 15 students that day, one was absent. Roig stated that the children initially placed themselves into the bathroom. When she came in, Roig stated that she put the littlest one on the toilet paper dispenser for a moment and held her there with one arm as she moved the kids around. Roig stated that she picked up two or three children and placed them behind the door because she could not close it. At one point, there were 5-6 kids standing on the toilet, all at once, so she could make room, and only one child remained there the whole time. Roig stated that she stood along the wall near the toilet paper dispenser, across from the door, and she told the children in front of her to crouch down. Roig stated that she locked the door and left the light on. Prior to closing the door, Roig stated that she pulled the wheeled bookshelf in front of the door. Roig stated that it was about 6 feet high and 4 1/2 feet wide. Roig clarified that it was light and on wheels, a child could push it. Roig stated that she had the kids in the bathroom and in place in under a minute. Roig stated that she was in the bathroom for about 40 minutes. Roig stated that her children knew what was going on and stated to her that the " bad guys were shooting." Roig stated that she told the children that the bad guys were out there and they had to wait for the good guys.

Roig stated that when the SWAT team came and all the children were brought out of the bathroom, they all went out and took a left down the hallway. Roig stated that the doors to the rooms were closed and they did not see anything. Roig stated that she would not open the door for the SWAT team and eventually they got the keys and unlocked the door for her.

Roig stated that to her, she never heard the shooting stop. She stated that, in her opinion, she estimates the shooting to have gone on for about 8 minutes. Roig stated that she knew the shooting sounds were close but could not tell where. Roig stated that she could not tell if the shooting was in her hallway or in the hallway of the cafeteria. Roig then appeared to have remembered something and stated that there was a break in the shooting. Roig stated that the only break she heard in the shooting was when she ran out of the bathroom to go get her cell phone, which she could not find. Roig also stated that she heard a female voice pleading "oh please no." Roig clarified for us verbally, that she initially heard the gunfire, she got the kids into the bathroom, she heard a break in the shooting and ran to get her cell phone, got back into the bathroom, and then heard the pleading and the gunfire started again. Roig stated that she does not recall any children's voices outside of her room, she does not recall children screaming and the pleading sound was the only adult voice she heard. Roig also verbally stated to us that she could not tell us the movement of the gunfire because she couldn't even tell herself where it was other than in the building.
