--School Visit Report--

01 02 03 12

Action Taken: On 6/6/13, this Detective, Detective Jewiss #336, Trooper Sawyer #340 and Newtown Police Department Officers Silver and Chapman, responded to the Sandy Hook Elementary School, 12 Dickinson Drive, Sandy Hook, CT, for a prearranged school visit with 01 02 03 12

01 02 03 12 family had not been present for the initial group family meeting when the majority of the known information was shared with the families of the decedents. The 01 02 03 12 had previously met with this Detective and Detective Jewiss privately to discuss some specific details of the event as well as some information pertaining only to their daughter on 12/14/12.

The 01 02 03 12 were provided, in part, with the following information:

-a general review of the timeline of the event, with clarification regarding where the shooter parked outside the school and his path of travel once he exited his car

-an explanation of the possible scenarios for the sequence of shooting in the two classrooms

-clarification of the movements within classroom #12 (Roig)

-Officer Chapman showed the ^{01 02 03 12} where he encountered ^{01 02 03 12} and the path he traveled when removing her from the classroom and school -some specific information pertaining to ^{01 02 03 12} was relayed by Officer Chapman

-some specific information pertaining to sequences of rifle reports as heard by Officer Chapman upon arrival was relayed

-some discussion was had regarding the new bill that was passed which would preclude the release of any photos with victims depicted in them -some discussion as to what the probability of release for the MVR (in-car camera) footage and audio from the 911 calls is

-specific details about the movements of staff and students within the room prior to and during the shooting as relayed by surviving students

-information pertaining to some vocalizations and statements reportedly overheard by staff and a student which are believed to have been uttered by the shooter and/or a student and where they may have occurred

-clarification of the difference between the much publicized "final report" and the overall investigative report and when those may be available to the public

-information pertaining to the future plan for the school and potential dates for the demolition, as explained by Officer Silver

The 01 02 03 12 and the officers present discussed the existence of some photographs which include several pictures of Officer Chapman carrying their daughter to a waiting ambulance. The 01 02 03 12 are aware of the images and stated that they have been in contact with the newspaper and were advised that the images are property of the paper but that they are kept in a protected location and will not be published. The 01 02 03 12 advised that they remain unsure of the proper course of action for the situation and want to eliminate the possibility of those images being released, so they will remain vigilant in monitoring the situation.

The 01 02 03 12 were afforded some time to privately reflect in 01 02 03 12 classroom and were given some documentation with agent contact information from the I.R.S. relative to any potential identity theft issues or fraudulent use of 01 02 03 12 social security number prior to clearing the scene.

The status of the case remains actively under investigation.
