Action Taken:

On 12/14/21012 at approximately 0940 hours, Troop A central dispatch received a 911 call via The Newtown police department of a possible active shooting occurring at the Sandy Hook elementary school located at 12 Dickerson Drive in Newtown, CT. Newtown P.D. requested assistance from all available law enforcement in the immediate area and proper safety precautions (Vest, Raid jackets, etc).

I assumed the position of Troop A Desk Trooper and began to broadcast the exact directions to the location and redirected all available units. I also deployed Troop A shotguns and ammo to responding units.

As the Troop A central dispatch became occupied with all incoming 911 calls and radio traffic, I began to monitor Danbury and Newtown P.D. channels and began to dispatch all important suspect(s) and vehicle information on the air.

With the assistance of Troop A Head Clerk Marie Grove, I then called the following hospital's Emergency room head nurse and placed them on emergency standby:

We maintained and continued communications with the hospitals and relayed information developed. I continued to direct incoming command staff and ESU/Major Crime units to the scene. All of Troop A's Town Selectmen were directed on safety precautions for their respective towns.

All CSP Chaplains were directed and staged at the Troop A Roll Call room. At approximately 1023 hours, I ordered in all Troop A evening shift and numerous off-duty personnel and had them assume patrol assignments.

I continued to assist all personal with communications until relieved by the evening shift Desk Trooper.
